Kindergarten tuition at Tobin Beaudet Schools is an annual fee. Their monthly installment is deducted through EFT on the 25th of the month (or the Friday prior if the 25th falls on a weekend) beginning on June 25th and ending on May 25th. I understand this contract to be binding and I will be responsible for the full tuition should I break this contract for any reason.

Afterschool tuition is a blended rate. Your afterschool tuition includes all non-school days, all early release days, all snow days and all vacation days in which your child is enrolled, from your child's first day of school through your child's last day of school. Transportation is included in this fee as well as a pizza lunch on all early release days. I understand that once this contract is signed: A 45-day written notice is required for any Afterschool schedule changes and I am responsible for the tuition due until the 45 days is up. I understand that I may request to add days based on availability in which case a new contract will be signed. I am unable to switch days. Days may be added based on space availability. I understand that the one time per family application fee of \$75 is non-refundable. I understand that the Last Half Month (LHM) payment is required upon enrollment. The LHM is collected for the number of days that your child is initially enrolled. This payment will be applied to your child's final tuition payment, which is due May 25th (payment #10) unless you continue enrollment for the following year. The LHM is credited to the last payment (payment #10) only if written notice is received in the office by March 1st. If I terminate prior to June, the LHM is forfeited. I agree to comply with all policies.

Tuition payments remain the same regardless of holidays, vacations, sickness or closing beyond our control. Families with two or more children in the program are entitled to a 10% discount off the lower rate paid. There is a \$30 overdraft fee applied for all returned transactions, which is automatically deducted through EFT.
